Article 3 - 6		Introduction of rule; Promotion and Relegation between State League and NPL has been restructured to include the 3 rd and 4 th placed State League Teams at the conclusion of the season, and the 11 th placed NPL Team at the conclusion of the season. Promotion and Relegation between State League and the Amateur League can potentially include the 3 rd placed Amateur League Team at the conclusion of the season, given there is a vacancy in the end of Season Play-offs.
Article 3	Paragraph 3	Amendment to rule; State League Clubs who are eligible for promotion to NPL rather than going through an audit will be required to complete the process of Football West and Football Australia's NPL Club Licensing System to obtain an NPL License ahead of potential promotion.
Article 14	Paragraph 2	Amendment of rule; Clubs can now list up to 25 players on their First Team Player Roster.
Article 14	Paragraph 3	Introduction of rule; All Players who have signed a professional contract must be placed onto the First Team Player Roster
